General Procurement Notice

The Government of Lesotho (GoL), acting through the Lesotho Millennium Development Agency - (LMDA) (the “Client”), intends to apply the GoL Funds to eligible payments under the Contracts for Goods, Works, Services and Non-Consulting Services. Payment by GoL will be made only at the request of Lesotho Millennium Development Agency and will be subject, in all respects, to the provisions of the Millennium Challenge Account (MCA-Lesotho) Authority Act No.1 of 2008 as amended by the MCA-Lesotho Authority Act (Continuation) Legal Notice No. 151 of 2013, including any restrictions on the use of GoL Funding and conditions to the Disbursements.

The Period covered by this General Procurement Notice is April 2021 to March 2023. The requirements of the programme for April 2021 to March 2023 include the Non-Consulting Services, Goods and Works as per Table 1 below

All Procurements will be subjected to competitive bidding processes except for two (2) procurements: Human Resources Information System (HRIS) and Support and Maintenance of Customised Accounting and Reporting System.
