Lesotho Millennium Development Agency (LMDA)**

**General Procurement Notice**

The Government acting through the Lesotho Millennium Development Agency (LMDA) intends to apply the Government of Lesotho (GoL) Funds to eligible payments for contracts for goods, works and Services. Payment by GoL will be made only at the request of Lesotho Millennium Development Agency and will be subject in all respects to the provisions of the MCA-Lesotho Authority Act No.1 of 2008 as amended by MCA-Lesotho Authority Act (Continuation) Notice No 151 of 2013, including any restrictions on the use of GoL Funding and conditions to the Disbursements.

This General Procurement Notice (GPN) amends the one that published local newspapers: Public Eye Newspaper on June 15, 2018, Lesotho Times Newspaper also on June 14, 2018. The Period covered by this General Procurement Notice is April 2019 to March 2021. The requirements for Goods, Services and works are detailed below:
